October 10 ZOOM Meeting

Hints:

1. Meeting can be accessed through cell phone, desk top computer, laptop.
2. Position your camera so we can see your face. (not your body, breakfast, furniture, etc.)
3. Mute yourself while others are speaking. (Participants can hear you talking to family members, making comments, coughing, etc.)
4. Invite family, friends, neighbors to “ZOOM” with us.

NWD MAILER

Our trifold mailer will be mailed on Wednesday, September 30. We considered that mail delivery may be slower than normal (another gift from the Trump administration). We will be getting a digital copy and those who access the newsletter through your email will receive a copy.
